Bids received in the Business Office after the Submittal deadline shall be returned unopened and will be considered void and unacceptable. The BOCES is not responsible for lateness of mail, carrier, etc. and the date/time stamp in the Business Office shall be the official time of receipt.

**C. Altering Bids**

Bids cannot be altered or amended after Submittal deadline. Any interlineation, alteration or erasure made before opening time must be initialed by the signer of the Bid, guaranteeing authenticity.

**D. Rights to Accept or Reject**

The BOCES reserves the right to reject any or all bids, in whole or in part, to waive any and all informalities, and to disregard all non-conforming, non-responsive, or conditional bids.

**E. Terms of Sale**

**1. Minimum Acceptable Bids:**

- No minimum bid for the vehicles
- 2. These vehicles are being sold in “As Is” condition in their current location.
- 3. The successful bidder must pay for the surplus vehicle in cash or by a bank certified check upon or before removal from the BOCES Instructional Services Center, Plattsburgh, NY premises.
- 4. The successful bidder shall, at their own expense, be responsible for the pick-up and removal of the surplus vehicle from the BOCES Instructional Services Center, Plattsburgh, NY location within 10 days of being awarded the bid.
- 5. The sale will be without regard to race, color, religion, national origin, sex, age or marital status.
- 6. In the event of an unforeseen school closure, the bid opening will take place on the following business day that the BOCES Offices are in operation. The bid opening would take place at the same location and at the same time previously stated in this invitation to bid.
