New Visions Medical Careers Information for Candidates and Parents

Description:

The CV-TEC New Vision Medical Careers Program is designed as a **career immersion** program for high achieving seniors. New Visions students have the unique opportunity to receive a theoretical and practical introduction to their career field of choice.

Through academics, site visits, guest speakers, mentoring and a senior project, New Visions students work at a level that prepares them for the college environment. Students get a jump-start on their futures by developing advanced writing, communications, problem-solving skills and taking a first-hand look at a chosen career field.

Students can earn high school academic credits as well as college level credit. Those enrolled will spend one-half of the school day at their home school and the other half at the New Vision sites participating in classroom instruction and work site rotations with professionals in the field.

Qualifications for Admission:

CV-TEC will enroll <u>seniors</u> in the New Visions Medical Careers Program. We encourage highly motivated, adaptive, high school juniors to apply:

- Students must have a minimum of 3 years Regents Math*
- Students must have a minimum of 3 years Regents Science* (chemistry preferred). AP, CAP or Bridge Science considered in place of chemistry if district scheduling precludes chemistry.
- Students **must** have a cumulative average of 85% or higher
- Students must have excellent communication skills such as writing, speaking, and listening
- Previous healthcare exposure through employment or volunteer work preferred
- Must submit a writing sample see attached
- Must have 2 Teacher Evaluations and 1 Counselor Evaluation

*The <u>only exception</u> is for currently (24-25) enrolled CV-TEC Allied Health students. Those students must submit an ACT <u>or</u> SAT score in lieu of meeting the Math and/or Science requirement above. It is also recommended that one of the teacher evaluations comes from the student's CV-TEC Allied Health teacher.

Students Applying to more than one CV-TEC New Visions Program:

Students <u>may apply for both</u> the New Visions Medical Careers Program and the New Visions Applied Engineering Program at CV-TEC. Please note:

- Both individual applications should be completed and submitted.
- One interview will be scheduled for both program applications.
- Applicants will be required to state their program first choice at the conclusion of the interview.

New Visions Medical Careers Application Directions & Selection Process Due February 28, 2025

PHASE I:

To the applicant:

- 1. Complete the Student Data Form (Page 4). Please do not leave anything blank.
- 2. Write an essay following the guidelines on page 5.
- 3. Give the enclosed confidential teacher evaluations to two teachers and ask them to return the completed forms promptly to your high school counselor. **Keep in mind submission deadline to CV-TEC**.
- 4. Return the data form & essay to your high school counselor.

To the counselor:

- 1. Complete the Counselor Evaluation Form.
- 2. Provide the applicant's transcript, including grades for junior year courses in progress. (ACT/SAT scores are <u>only required for currently seated Allied Health</u> students that may not have met the Math or Science requirements due to scheduling.)
- 3. Two teacher evaluations should be forwarded to you by student-selected teachers.
- 4. Submit the application packet to CV-TEC. Each application packet must include the following items:
 - Completed Student Data Form
 - Student Essay-See Guidelines
 - Student Transcript (Please include GPA and Class rank if not reported on Transcript)
 - SAT/ACT scores, if available (<u>Only required for current Allied Health Students</u> that have not met the Math or Science Requirements due to scheduling conflicts)
 - Two Teacher Evaluations
 - One Counselor Evaluation

All the required components must be <u>received electronically, OR postmarked, in their entirety,</u> by the deadline of <u>February 28, 2025</u> to be considered.

PHASE II:

<u>Candidate Interview</u>: Students who are selected to move forward in the selection process will be required to participate in an interview with the New Visions Medical Careers Committee. Students will be notified individually by <u>e-mail</u> if they have moved on to the Phase II Interview and the date/time their interview has been scheduled. This information will also be shared with the student's School Counselor via e-mail. This is a professional interview. Applicants should dress accordingly.

PHASE III:

<u>Notification of Acceptance</u>: Applicants will receive notification of their acceptance status and session assignment via <u>e-mail</u>. School Counselors will be notified via e-mail which students have been selected and to which session they have been assigned. Session assignments are unable to be changed.

- O What are your career goals?
- What colleges are you considering upon graduation?
- O What are your favorite subject(s) in school?
- o List your interests/activities outside of school.
- o List prior healthcare experience (paid or volunteer) you have had. (Personal illness, injury, or medical procedures are not considered experience)
- o State your qualifications that make you suited for the New Visions Program.
- o State your reasons for interest in this career field.
